Why OSINT Before Subpoenas?

The Problem

Your client has been harassed by anonymous burner phones and VPN-masked IPs. You need to file subpoenas, but: - Which targets are worth pursuing? (Some cost \$5K+ and yield nothing) - How long will it take? (Verizon: 3-4 weeks, International: 6-12 months) - What's the success rate? (VPN providers: <20%, Domestic carriers: 85%+)

The Solution

OSINT investigation **before** filing subpoenas: - Identify actionable targets in 24-72 hours - Rule out expensive dead ends (international VPNs, Tor nodes) - Provide cost/timeline/success rate estimates for each target - Deliver court-ready reports with evidence documentation

1. Pre-Subpoena Intelligence

What We Do: - Analyze phone numbers (identify VOIP carrier, social media links) - Analyze IP addresses (WHOIS, geolocation, VPN detection) - Cost-benefit analysis (which subpoenas are worth filing)

Typical Engagement Models

Model 1: Pre-Subpoena Consultation

Scope: Analyze existing evidence (phone numbers, IPs, emails) and recommend subpoena strategy

Timeline: 2-3 days

Deliverable: Executive summary with subpoena targets and cost/success estimates

Recent Results

Case 1: Harassment Investigation

- Challenge: 6+ months harassment, 4 burner phones, anonymous emails, 8 IPs
- Timeline: 72 hours to actionable targets, 1 week to comprehensive report
- Results: Identified 3 subpoena targets (\$275 total), ruled out \$10K+ in dead ends
- Outcome: Attorney filed within 7 days, case progressing to perpetrator ID

Case 2: Employment Dispute

- Challenge: Anonymous Glassdoor reviews, suspected former employee
- Timeline: 5 days for writing style analysis and account correlation
- Results: Linked reviews to ex-employee via linguistic profiling and timing patterns
- Outcome: Settlement negotiations strengthened by documented evidence

Case 3: Fraud Investigation

- Challenge: Fake LinkedIn profile, stolen credentials, business impersonation
- Timeline: 3 days for reverse image search and social media correlation
- Results: Identified real person behind fake profile, documented extent of impersonation
- Outcome: Cease & desist effective, criminal referral filed

Process & Timeline

Result: OSINT investigation saves \$5K-25K in dead-end subpoenas while accelerating timeline by weeks or months.
