Case Study: Harassment Investigation

Challenge: Client received 6+ months of harassment via burner phones, anonymous emails, and website contact forms. Attorney needed actionable subpoena targets.

Investigation Timeline: - **Day 1:** Phone intelligence identified ONVOY as VOIP carrier for all 4 burner numbers - **Day 2:** IP analysis identified Loews Hotel Orlando as high-value subpoena target - **Day 3:** Text analysis revealed harassment patterns and threat levels - **Week 1:** Comprehensive report with 3 prioritized subpoena targets delivered

Results: - Identified actionable subpoena targets (ONVOY, Loews Hotel, Gmail) - Ruled out expensive international subpoenas (VPN endpoints, low success rate) - Cost-benefit analysis: \$275-325 for 3 domestic subpoenas vs. \$5,000+ for international - Attorney filed subpoenas within 1 week of receiving report

Value Delivered: - Faster than Verizon subpoena (OSINT found same IPs in hours vs. weeks) - Lower cost (avoided \$5K+ in dead-end international subpoenas) - Actionable targets with clear next steps for attorney
